PLANNED PARENTHOOD POST-ROE

Roe is gone, but we're still here.

On June 24, 2022, the Supreme Court handed down its decision in the *Dobbs v. Jackson Women's Health Organization* case, overturning *Roe v. Wade* and eliminating federal protections for abortion. Minutes after the ruling was announced, Missouri became the first state to completely ban abortion, with many other states across the Midwest and South following suit. Tens of thousands of patients seeking abortion have been displaced, forcing them to search for the support and resources they needed to access high-quality sexual and reproductive health care.

Your support helped Reproductive Health Services (RHS) build reproductive freedom in bold and innovative ways that will continue to support every person's ability to access health care, no matter what.

- The Regional Logistics Center (RLC):
 - **Directly provided \$826,580 in travel and lodging assistance** and delivered **\$2,828,488 in financial support** to patients.
 - **Provided no-cost navigation for 4,882 patients** experiencing a rapidly changing abortion landscape across the country.
 - **RHS expanded the hours and days of operation** at the Fairview Heights clinic, plus **increased eligibility for procedural abortions** from 24 weeks **up to 26 weeks** in pregnancy.
 - **Provided abortion services to 9,140 patients** – 41% from states other than Missouri and Illinois – predominantly from the South.

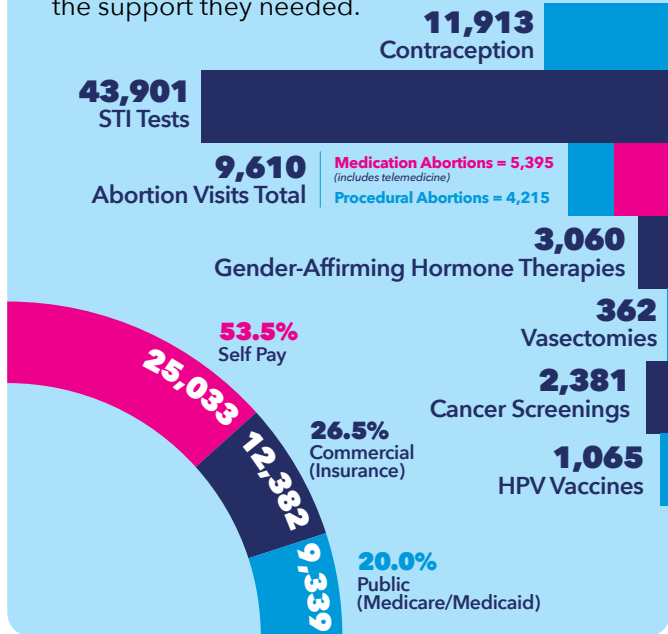

HEALTH CARE

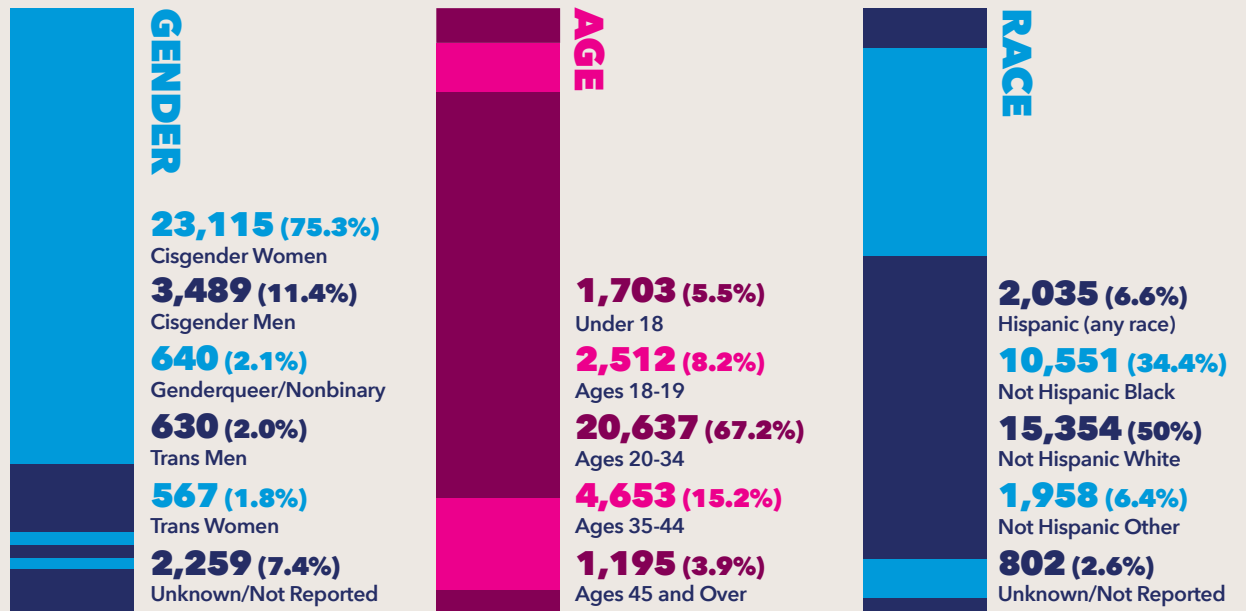
In 2022, Planned Parenthood of the St. Louis Region and Southwest Missouri (PPSLRSWMO) continued to prioritize expanded access to high-quality, patient-centered, equitable health care. **No matter what.**

TRANSGENDER CARE

PPSLRSWMO proudly provides gender-affirming care to patients – with or without insurance – through the **TRANSforming Community, TRANSforming Care (TC2)** program in partnership with Metro Trans Umbrella Group and Missouri Foundation for Health.

What does Gender-Affirming Care at PPSLRSWMO look like?

We offer gender-affirming hormone therapy and behavioral health to patients 16 years and older, gender-affirming surgery (vasectomy, hysterectomy, and oophorectomy) to adult patients, plus access to the full range of PPSLRSWMO sexual and reproductive health care services. TC2 patient navigators provide essential non-clinical support, like referrals and letters of support for additional care, crisis management, injection support, and coordination of care.

EDUCATION

The PPSLRSWMO education team's mission is to provide comprehensive and age-appropriate sex education that empowers individuals to make well-informed decisions regarding their sexual health across their lifespan and to provide educational services and anti-oppression training in a manner that promotes social justice and freedom from all forms of oppression. **No matter what.**

Your support helped the Education team:

- Publicize and grow the **Sexuality Educator Antiracist Training (SEAT)** program by conducting market research with other Planned Parenthood affiliates, establishing future partnerships, and implementing SEAT with our peer educator students in training.
- Expand curricula for specific populations including pregnant and parenting teens, formerly incarcerated people, and older adults.
- Increase students in the **Teen Advocates for Sexual Health (TASH)** program, a group of teens (grades 9-12) representing diverse backgrounds and regions dedicated to learning about sexual health, sexuality, and how to be advocates in their communities.
- Lead 274 education and training sessions across the region, empowering 1,908 participants to make well-informed decisions regarding their sexual health.

RESEARCH

PPSLRSWMO continues to use research to drive innovation, improve standards of medical care, and break down barriers to increase access to sexual and reproductive health care services.

Your support helped the Research department:

- Engage more than 600 patients in 11 different research projects.
- Register over 350 patients in a study evaluating patient acceptability of telemedicine abortion.
- Enroll more than 100 patients in a national study about pre-exposure prophylaxis (PrEP), particularly among disproportionately affected populations such as Black and Hispanic people and cisgender women.

ADVOCACY

Advocates of Planned Parenthood of the St. Louis Region and Southwest Missouri is a 501(c)(4) nonprofit organization that primarily engages in education, lobbying, organizing, and other social welfare activities.

Our work is no longer just about protecting a right – it's about transforming the systems that decide who can control our bodies and futures.

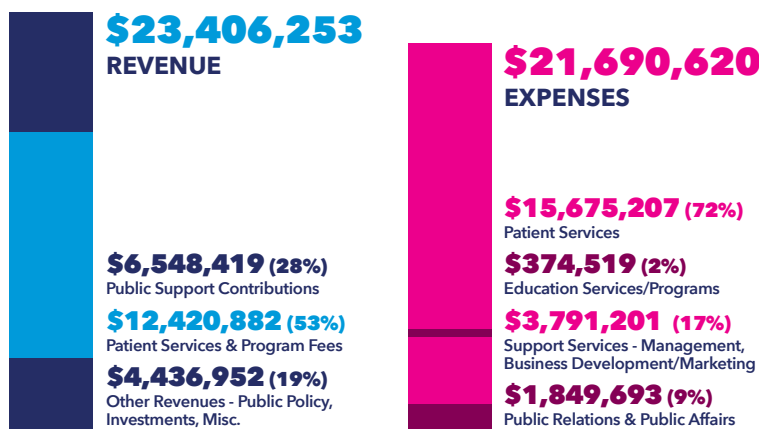
In 2022, we continued to strengthen our movement by educating, motivating, and mobilizing the fight for reproductive freedom – building momentum to leverage our powerful infrastructure and support to reach voters, remind them of what's at stake, and turn their outrage into action.

Your support helped Advocates of Planned Parenthood of the St. Louis Region and Southwest Missouri and Planned Parenthood Votes - St. Louis and Southwest Missouri (PAC):

- Gather with more than 700 Missourians from across the state to **Protest for Trans Rights** on March 29, 2023, at the state Capitol.
- Work in coalition to protect the full range of reproductive and sexual health care including abortion and gender-affirming care in Illinois. This resulted in a **comprehensive bill**, signed into law by Illinois Governor J.B. Pritzker on January 13, 2023, designed to protect patients and providers. This was a monumental step forward for Illinois and solidifies its status as a **haven state** for generations to come.
