Affordable Technology

 - This program provides 4G LTE internet service at a reduced price, and computers and/or related technology equipment and repairs available to individuals for free or at a reduced cost.
 - Recipients must be below the 200% poverty level or be currently enrolled in an income-based government assistance program.
 - Devices purchased through PCs for People are for recipients who meet eligibility requirements.
- <u>Free Geek Twin Cities</u> provides reduced price of computers and computer parts. Provide income-based desktop computers starting at \$30.

Minnesota Telephone Equipment Distribution Program

• If you meet certain eligibility requirements, you may qualify to receive telecommunications equipment at no cost through Minnesota's Telephone Equipment Distribution (TED) Program. The TED Program loans telecommunications equipment to people who are hard of hearing, deaf, deafblind, speech disabled, or physically disabled. If you do not qualify, TED Program staff can provide you with a directory of vendors where equipment can be purchased.

- 1) Find a space that is private and confidential for you to discuss your health,
- 2) Data encryption is for best protection, use sites with HTTPS in the browser, or use a VPN service to keep your data safe.
- 3) Be cautious and/or avoid suspicious sites and links that require:
 - o pay for access or enter your credit card information,
 - Require excessive personal information such as social security numbers, date of birth, full name, and addresses.
 - To download directly from links onto your laptop/phone without secure encryption in their browser (https)
- 4) Limit file sharing in these public spaces unless a website is encrypted.
- 5) Review your security settings on your device and the internet access you use.

Federal Communications Commission (FCC): Affordable Connectivity Program (ACP)

What is the Affordable Connectivity Program?

The Affordable Connectivity Program is a federal broadband discount program that provides eligible households internet service up to a \$30 credit on their monthly bill. To learn more information about ACP visit:
