There is no legal way that data collected in giving out vaccinations can be used for civil or criminal prosecution, including immigration enforcement. Immigration status should not interfere with your ability to live a healthy life.

For every million doses about 50 serious reactions have happened. The risk of adverse reactions after vaccination are extremely low- especially when you compare it with the likelihood of becoming seriously ill from COVID. Multiple agencies are responsible for consistent oversight of vaccine safety. If unexpected patterns of reactions show up, we have systems in place to quickly identify them and take action.

There is currently no evidence that COVID-19 vaccination causes any problems with pregnancy or fertility. Over 30,000 pregnant people have been vaccinated (as of mid-April) and no unexpected outcomes have been observed related to the vaccination.
